

# 2024 Moth North American Championship Waszp Pacific Coast Championships October 18<sup>th</sup> – 20<sup>th</sup> 2024 NOTICE OF RACE

The Organizing Authority for the  
2024 Moth North American Championship and Waszp Pacific Coast Championships  
is Coronado Yacht Club

## 1. RULES

1.1. The regatta will be governed by the rules as defined in The Racing Rules of Sailing.

1.2. The prescriptions of US Sailing will not apply except the US Sailing Prescriptions to RRS 60.3(b), RRS 67 and RRS 76.1, which are stated in full below:

1.2.1. (RRS 60.3 (b) – Protests/Redress by Protest Committee) – US Sailing prescribes that a protest committee may (b) request redress for a boat or call a hearing to consider redress;

1.2.2. (RRS 67 – Damages) – US SAILING prescribes that: (a) A boat that retires from a race or accepts a penalty does not by that action alone admit liability for damages. (b) A protest committee shall find facts and make decisions only in compliance with the rules. No protest committee or US SAILING Appeals authority shall adjudicate any claim for damages. Such a claim is subject to the jurisdiction of the courts. (c) A basic purpose of the rules is to prevent contact between boats. By participating in an event governed by the rules, a boat agrees that responsibility for damages arising from any breach of the rules shall be based on fault as determined by application of the rules, and that she shall not be governed by the legal doctrine of “assumption of risk” for monetary damages resulting from contact with other boats.

1.2.3. (RRS 76.1 – Exclusion of Boats or Competitors) – US Sailing prescribes that an organizing authority or race committee shall not reject or cancel the entry of a boat or exclude a competitor eligible under the Notice of Race and Sailing Instructions for an arbitrary or capricious reason, or for the reason of race, color, national origin, gender, sexual orientation, or age.

## 2. ELIGIBILITY AND ENTRIES

2.1. The regatta is open to boats of the International Moth Class and Waszp Class

2.2. The Official Registration and Entry Forms are available at

2.3. Eligible boats may enter online by paying the entry fee and completing and submitting the Official Registration and Entry Forms by October 17<sup>th</sup>, 2024. Competitors are not considered registered until all completed Official Registration and Entry Forms and entry fees are submitted to the Organizing Authority.

2.4 Proof of current class membership.

### **3. FEES**

3.1. The entry fee shall be US \$125 per boat.

3.2. Eligible entries must be received and paid on or before October 1<sup>st</sup>, all registration after Oct. 1<sup>st</sup> will have a late fee \$50.

3.3. Entry fees paid but canceled will not be refunded

### **4. SCHEDULE**

Race first warning 1200, 4 races scheduled

After Racing debrief and snack

**Sunday, October 20<sup>th</sup>**

First race warning 1200, 3 races scheduled

No warning after 1500

### **5. MEASUREMENT**

Boats may be subject to inspections at any time during the regatta.

### **6. SAILING INSTRUCTIONS**

The Sailing Instructions will be available on line prior to, but not later than October 16<sup>th</sup>, 2019.

Provisional Instructions may be available prior to that.

### **7. VENUE**

Races will be held on South Bay San Diego Bay. Boat storage and launching will be from Coronado Yacht Club.

### **8. COURSES**

8.1. The courses will be Windward/Leeward as described in the Sailing Instructions

### **9. PENALTY SYSTEM RRS**

44.1 and RRS 44.2 are each changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

### **10. SCORING**

10.1. Three (3) completed races are required to be completed to constitute a series.

10.2. The Low Point Scoring System, RRS A2, shall apply except that:

10.2.1. When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.

10.2.2. When from 5 to 8 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

10.2.3. When 9 or more races have been completed, a boat's series score will be the total of her race scores excluding her two worst scores.

## **11. SUPPORT BOAT/PERSONNEL**

11.1. Support/coach/non-race committee spectator boats shall register at the check-in table on October 18<sup>th</sup>

11.3. Rules governing the conduct of all support persons or boats will be in accordance with RRS 3, RRS 60.3 (d) and RRS 64.4.

## **12. PRIZES**

Will be awarded to the top three competitors overall and the first junior (aged 20 years or younger as of October 18<sup>th</sup>, 2024)

## **13. LOGISTICAL INFORMATION**

15.1. Boats and Trailers may arrive at Coronado Yacht Club no sooner than October 16<sup>th</sup> and must be removed by end of the event.
